Information we collect and how we use it

We may collect the following types of information:

Information you provide – When you sign up for access to the contents of this site, we ask you for personal information. We may combine the information you submit under your account with information from other A+ Interactive MATH services, its parent company A+ TutorSoft, Inc. or third parties in order to provide you with a better experience and to improve the quality of our products and services.

The administrator of this site will have access to your account information including your email.

Information Log – When you access A+ Interactive MATH products and services on this site via a browser, application or other client, our servers automatically record certain information. These server logs may include information such as your web request, your interaction with a service, Internet Protocol address, browser type, browser language, the date and time of your request and one or more cookies that may uniquely identify your browser or your account.

User communications – When you send email or other communications to A+ Interactive MATH, we may retain those communications in order to process your inquiries, respond to your requests and improve our products and services.

Affiliated A+ Interactive MATH Products & Services on other sites – We currently offer (or may offer in future) some of our products and services on or through other web sites. Personal information that you provide to those sites may be sent to A+ Interactive MATH (an A+ TutorSoft, Inc. company) in order to deliver the product and/or service. We process such information under this Privacy Policy.

Other sites – This Privacy Policy applies to A+ Interactive MATH (an A+ TutorSoft, Inc. company) products and services only. We do not exercise control over the sites displayed as a result of links from within our products and services. These other sites may place cookies or other files on your computer, collect data or solicit personal information from you.

In addition to the above, we may use the information we collect to:

- Protect the rights or property of our users.

Information sharing

Information security
